Closed incident reports are those in which DDD Quality Improvement has completed all investigations and has rendered a final disposition.

In total, the District North Independent Oversight Committee reviewed 3,614 reports. Cynthia McKinnon reviewed all reports as the Senior Co-Chairperson. The remaining members equally divided a second copy of the reports to ensure accuracy.

Suicide incident reports are for attempts, suicidal idealizations (written or verbal), and member threats of suicide. If a member commits suicide, DDD Quality Improvement issues a death incident report is issued.
