Sophie Legaspi with United Health Care Community Plan (UHCCP):

Began that she did not have much updates. She is reporting that UHCCP is still providing member outreach during the COVID-19 crisis.

Summer Kamal/Janet Holtz with Mercy Care: Added Mercy care continues to keep helping with assigned case managers to aid the members with COVID-19.

Is the Pub Fid also monitoring the accounts and how are they doing the spend down of the members? Jeffrey Yamamoto help answer that question by stating that the benefits coordinator for DDD receives and monitors the report either monthly or weekly? He will find out for the IOC. De freedman suggests that the benefits coordinator be invited to the next meeting. Jeffrey agreed he would invite her.

De Freedman asked if Nicolette Fidel could be requested to attend meeting and go over why the DTAs are having problems following behavior plan goals and what is the solution to having them do so.
