**Kin Counts:** This is kin counts. I understand the changes in regards to the Article 9. I think it has been not, they're not caring forward. Am I right?

**Suzie Hessman:** That's correct. There was an email sent out. from Zane director Zane that said, That currently, they are not going to implement any of the changes. To Article 9 and that he would address that further if we wanted at the statewide meeting. Do you have any further information on that Jeffrey?

**Jeffrey Yamamoto:** No, that was actually going to be one of my updates on that. So he did send that email out on December 5th. Their DDD is not going forward with it at this time, and the assistant director was going to address that during the statewide. IOC chairs meeting.

Suzie Hessman: Jeffrey or Joan since Leah is not on the call. Do either of you have any comments on any of the policy updates that came out this month.

Joan McQuade: This is Joan. No, I do not.

**Michelle Rademacher:** And this is Michelle. No, I do not, however what you received was the early notification. IOC has 30-day prior notice now, So you're getting it a little early?

Suzie Hessman: Okay.

**Suzie Hessman:** Then if nobody else has any questions or comments on policy or legislative issues? I will go ahead to agenda Number five. DDD staff update.

Suzie Hessman: Kin you raised your hands. Go ahead.



**Kin Counts:** Yeah, yes, it regards to. I understand that there's this change coming up with regards to the EVV system about how providers are going to like clock in clock out, or something like that, due, according to DDD.

Kin Counts: I don't know. I'm changes or recommendation, whatever. So it's that correct. Joan.

Joan McQuade: I If you're looking at you're discussing the EVV system, the electronic visit verification.

Kin Counts: Right, there's some kind of a requirement from DDD with regards to that.

**Suzie Hessman:** It's a requirement that AHCCCS is requiring. For any services that are provided on an hourly, kind of basis, so therapy services Habilitation, respite things like that that are not done on a daily basis so that they're verifying that the individuals are actually, it's a GPS.

**Suzie Hessman:** Gathering, you know, like your Google maps. So it would gather that the person is there and they log in verifying that they're actually on location and then log out when they're leaving, so that they have confirmation that people are not fraudulently claiming that they're Participating in hours, when they're not.

Suzie Hessman: James.

James Maio: Are you asking about the differential that AHCCCS is offering to vendors who are using EVV, That just came out. Or that it's, you know, that came out. I mean, I know that that also was a new thing that they're offering. For new vendors. Are you asking about if there's any new rules or new...

Suzie Hessman: My understanding is starting January 1st,...

Kin Counts: because,

Suzie Hessman: All vendors.

Kin Counts: Right.

**Suzie Hessman:** Providing services have to have the EVV in place. Otherwise they won't be appropriately compensated.

Kin Counts: Right? And it's just the logging in. I think they requires even, because I have parents that were saying, You know, that in live-in providers, then it's just that the clocking in and out is kind of. And I mean, for outside providers, yes, they come in and clock in and finish that job, they go out. believe, but then, for live-in providers is this kind of like, You know, many, many parents. I, they're so busy. That's what I heard from them. So busy, they forget. And, you know, the clock in clock out because, you know, they are in, you know, they are living there, you know, parents providers and, you know, people like that. So I'm just, you know, want to clarify that. You know what? What is going on with changes?

**Suzie Hessman:** I would ask the agency who you're working through. Because they should have that in place for you.

Kin Counts: Thank you.

Jeffrey Yamamoto: Sarah has her hand up.

Suzie Hessman: Hi Sarah. Go ahead.

**Sarah McGovern:** And this I'm assuming, my assumption is is that this is because they're going to be ending virtual services. So they want to be able to make sure that the providers are doing not doing their services virtually. Is that correct?

**Suzie Hessman:** I don't know for sure, my understanding is just that it's a requirement from AHCCCS. For any of the services that are less than per diem,...

Sarah McGovern: Okay.

**Suzie Hessman:** you know, if they're if there's some kind of a like a live-in residential, then they're not doing it that way. But if it's Occupational therapy, speech therapy respite. Habilitation, Attendant Care. Housekeeping. Nursing services,...

Sarah McGovern: Yep.

Suzie Hessman: things like that. They have to use the EVV.

**Sarah McGovern:** Yeah, that was my understanding because our hab provider has to go back to in-person, no more virtual meetings and this way then when he clocks in then it shows that he's actually with my son and they're not I you know that he's on site.

**Kin Counts:** I think that required, they are also requiring parent providers or family providers live-in providers. Could do that as well. So, I mean, you know, that's what they were saying, that doesn't make sense. If you are already in a house all the time,

Suzie Hessman: Teresa.

**Teresa Brooks:** Yeah, I'm understanding What Kin is saying. It's... I can understand having outside providers coming in to to use EVV, but it's really burdensome for the parent providers to do this or live in providers. And it's really.

**Teresa Brooks:** Causing some issues, with some of the parents. I think that's what Kin was trying to say, if, if there's any

**Teresa Brooks:** any talk in the works. About having parents. Exempt from that parents and or living. Live-in providers.



Suzie Hessman: And I don't know again. I think that's ah, it's a requirement from AHCCCS. So I'm not sure.

Suzie Hessman: if that was a Federal Requirement.

**Jeffrey Yamamoto:** So, I'm not sure if on those questions ladies, I will say, I will give you a little bit of my update right now. which was going to be that there was not a

**Jeffrey Yamamoto:** It was not a town hall, being held for the month of December. But there will be one on Thursday, January 5th from six to eight PM. That would be a good question to bring up at that town hall. when they go to an open forum, To ask.

Jeffrey Yamamoto: Um, otherwise I will. I will.

Jeffrey Yamamoto: Ask around. On the OIFA team. And see what. I might be able to find it for you.

Last time I checked, I think it was yesterday the day before week three, and four were still. not reviewed and I'd be happy to Do some more. I mean since I didn't have any in November, For my week and then the other. I was just wondering what is considered the second week in December. Would it be the second full week? December days.

**Sarah McGovern:** That's why we're going to consolidate neglect into one category again because it does kind of get hard to differentiate which week. And then we inevitably miss a week here and there.
