Therefore, pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment will be limited to directing the IOC committee to respond to any criticism, or scheduling the matter for further consideration and decision at a later date.

The Committee may go into Executive Session to discuss or consider the appointment of new members and/or to discuss protected health information from incident reports and behavioral plans concerning members of the Division of Developmental Disabilities of the Arizona Department of Economic Security.
