Michelle Rademacher: I took a few notes during the meeting. There was some discussion about the DDPC doing work around Behavioral Health and the crisis response for individuals with IDD around the state. The DDPC, that's another council. They're the Commission Planning Council, excuse me, they're currently conducting a Statewide survey related to the lived experiences of individuals with IDD and their caregivers in seeking Behavioral Health Services and interactions with crisis response system around the state. So the results will be shared around early spring and they are now attending the quarterly Statewide meeting so that update on their current survey will be shared with the committee.

Michelle Rademacher: Also, there was discussion with the IOC around program Review Committee and behavior plans and issues related to it. Providers are having a hard time getting documents from Behavioral Health agencies and providers are having a hard time getting plans improved timely. This is all has already been made known to DDD Behavioral Health Administration and there is work that's going forward on that.

Michelle Rademacher: Katrien Filez from DDD PRC. She's one of the administrators. She spoke of a future plan, which is a behavior plan writer's guide. So on the behavioral health administration is working on helping their providers with a DDD Behavior plan template and then a writer's guide to go into more depth for each section on what expectations are for the behavior plans and they're hoping to finish that up to the first quarter of 2024 to share with qualified vendors and help increase the quality of behavior plans for our DDD members.

Michelle Rademacher: And then Zane had it update. I'm not sure Barb, did Leah give you an update to share at this meeting or I can share some of this information from Statewide if she did not.

Raising Special Kids is starting the family caregiver training in early March.

Ian Wilson UHCCP: A sure thing, so I'm Ian Wilson here with United Healthcare. I just wanted to put out that we'll be working with the DDD OFIA Mercy Care and OIFA and then Michelle to arrange a presentation here in Family Support Services in Arizona more to follow on that, but just gonna share. Thanks.

Keith Jansen: Okay, those were the only two I saw. Am I correct, Michelle?

Michelle Rademacher: Yes, that is correct.

Updates from DDD IOC Liaison

Keith Jansen: Okay, Michelle updates. ...

Michelle Rademacher: Okay.

Keith Jansen: your twin?

Michelle Rademacher: So as Ian was speaking, we have the health plan and DDD would like to provide a presentation to the IOC. They have a presentation that they'd like to put together on Peer and Family Support Services and they'd like to do that in March if the committee is okay with that. March is the tentative plan right now. The typical presentation does about; I don't remember the length of time but it would occur during the meeting. I wouldn't be an outside event. They would go ahead and do that during your monthly meeting if that's okay.

Michelle Rademacher: And then we've been letting the Committees know each month now in the meetings about their metrics what the data looks like for incident reports. For January incident reports, the committee members will have been given and that was as of last week. You were given 594 incident reports. This included 54 open and 540 closed reports. 17 questions were submitted in January to the district quality team based on review of those incident reports. And then additionally in January we did send a batch of backlog from August and you will see a batch of backlog coming in from October as well this month for February and that should have us caught up with all backlogs.

Michelle Rademacher: Once a month the DDD IOC Liaisons send an email out to the committee. We send that email Friday prior to your monthly meeting. And then that email contains several different documents. The main document included is the agenda used for the meeting but we also send you what we call metadata reports and those metadata reports are incident report data that we pull from our Focus Incident Management System. The IOC receives specific data from these reports. There are three different reports and the data is broken down by provider to consumer ratio. They are also broken down by member total incidents with provider and type and then there's also a six-month tally of Provider

incidents broken down by how many per type and category. If you have any questions on those reports just reach out to me and I would be able to help you out with that information.

Michelle Rademacher: And then the last bit of information I want to share today is the DDD Public Town Hall. I like to provide this every month. It is held Thursday, March 7th, and it is from six to eight pm. DDD is having some, Leah shared this with us in some other meetings, where they're having some speakers attend these town halls for 2024. In March, they have the Social Security Administration attending. In April, someone is going to attend and speak on Parents' Paid Caregivers on that waiver. In May, there, We'll have speakers from the Arizona Center for Disability Law and also Writers Voting Rights for People with Disabilities. Those are some of the examples of the speakers that will be in the town halls and the coming months.
