Under A.R.S. § 38-431.03(A)(1), (A)(2), (A)(3), the IOC may vote to go into executive session, which will not be open to the public. The Committee may go into Executive Session to discuss or consider the appointment of new members and/or to discuss protected health information from incident reports and behavioral plans concerning members of the Division of Developmental Disabilities of the Arizona Department of Economic Security.
