**Michelle Rademacher:** I just wanted to interrupt just quickly if possible just to talk about something procedural Don currently, you have two applicants that are at this meeting and they did just introduce themselves briefly. It's up to you if you want to go out of order, but if you would because the committee is rebuilding and we're low in membership. There's no vote at this time. You would either accept their applications not and you could speak with them a little bit more if you'd like to.

Don Harrington: so the applicants are Suzanne and who's the other one?

Michelle Rademacher: Cynthia that I say that right Yeah.

cintya catalan: Yes, it's Cynthia.

**Don Harrington:** They passed Larry's bar, right? then that's good enough for me. Welcome to IOC North Yeah, so Cynthia remind me that what kind of work you do?

**cintya catalan:** Yeah, so I actually work for a training company called apt here in Arizona and we provide training support for products going to clients homes and provide respite care Rehabilitation. So I make sure that I'm training with DDD guidelines.

Don Harrington: Okay, do you trained just for your company or do you go to other licensing?



**cintya catalan:** A little bit of both right now just for my company, but in the past I've done actual other agencies through just private pay. It's a little bit of everything in prior to that. I did work in education with students who specifically had autism and I was a program coordinator and I'm kind of familiar with ESA different forms of funding through just education and just kind of a little bit of everything.

**Don Harrington:** Okay, so Suzanne, so happy to have you here too as well. So that's gonna boost our I don't think I've ever had more than just one other members. So now we got four weee. That makes us important guys.

# **DDD Staff Updates**

#### Don Harrington: Okay, so we're with Christina

Christina Hedges: Perfect you bought me some time. So I appreciate that. Some updates that we have within the division. We are still continuing to run our PBS training. We actually had the trainer Clinic, I believe it was last week. We are now seeing that we have had over 7,000 direct support professionals and trainers complete the training and we're just seeing that number grow, which is amazing. I think I've spoken about this before but we are giving a pretest before the training and then a post-test after the training and when comparing those two tests we're seeing about a 22% increase in knowledge. So people are learning things during the training. we also are submitting or asking people to complete a survey when they are done with the training that really talks about the applicability of the training and how satisfied they were with the training and on a scale of one to five with five being the highest. We are seeing the average at I believe the latest numbers are 4.67. So people really feel like the training is not only kind of fun for them to take but it's really applicable to their jobs and who they might be, whether it's a caregiver professionally or as a family member. So that's awesome. I believe our latest numbers show that we have had 114 families or caregivers take the training through raising special kids. So we're seeing some really great things come from that Bridging the Gap conference for Behavioral Health Providers in Phoenix is going to be held on September 5th and 6th with September 7th being a special day just for bcbas. I'm sure Katrina is very excited about that. We had some really good feedback from our conference in Tucson. And so we're excited to do it again up in Phoenix it Desert Willow and that conference is really geared towards helping Behavioral Health Providers know how to better support DDD members as they go through Behavioral Health Services. The final thing that we have rolling out in an OIFA or CARES right now is we actually just yesterday opened up our registration for our self-care for caregivers conference. This is our second annual one. We held one conference last year in Phoenix and it got such positive feedback that not only are we doing it again, but we're doing it Tucson and in Phoenix this year. I don't want to our own horns or Be too optimistic, but hopefully maybe in the future we can come up to district North. I know it would be really great to be able to support the caregivers up there as well. Like I said, they're registration opened yesterday and I think for the Phoenix conference, we're already at over 300 registrants. So if you want to be a part of that conference, please please register as soon as possible. I can make sure that Michelle and Morgan send the links out to you guys.

Christina Hedges: I can speak to that a little bit Don. So the RSP that went out was not for MercyCare DDD line of business it was only for the long term care physical disabiliabled line of business. So anyone who is DDD and mercy care will not be affected.

**Don Harrington:** So the reason foundation for my question was I have a member that had a Mercy Care and he was told to find another carrier. So I directed them to United but I just didn't understand why. So I don't think so.

Ashley Mason: Was he apart of the ALTCS plan?

Don Harrington: I don't think so

Ashley Mason: I can speak more to this when you guys call on me. But if you were a part of ALTCS they sent out premature letters before the judge gave a recommendation. And now that he has given his recommendation everything is paused and that came out in the update this week. Everything is paused right now.

**Don Harrington:** but I would have to Okay, I have that update. it just didn't register. So I'll go back and look at that. any more questions Leah Gibbs is here.

Leah Gibbs: I am so very sorry that I am late. I've been on a call I couldn't get off the phone.

Don Harrington: you're forgiving. why don't you go ahead and introduce yourself?

**Leah Gibbs:** Good afternoon, everyone. I'm Leah Gibbs and I work for the division of Developmental Disabilities and I am our bureau chief for our cares Administration.

**Don Harrington:** Okay, we were just talking about rumors that I'd heard about Mercy Care because I had a member that was told that they had to change insurance companies. So yeah.

Don Harrington: We has some that you'll disperse.

Leah Gibbs: Has anyone been able to help you get some more information around that yet?

Don Harrington: But yeah, if you know any secrets.

Leah Gibbs: I don't know Secrets trust me Don.

**Leah Gibbs:** But I assume that you're aware that what happened was when the AHCCCS Administration was doing their Contracting for the new agency to provide long-term care services to the elderly and physically disabled program. So that's the other Long-Term Care Program in the state of Arizona. There's the one for the division the disabilities program and one for the elderly and physically disabled program. And when AHCCCS went through their request for proposal RFP the state Contracting process, they awarded that contract to two agencies. There was an agency Who challenged that award and they felt



that they should have been awarded and it was heard in front of it administrative judge and AHCCCS has announced that they have put a hold on the transition process. To the contractors that they awarded based on the findings from that administrative judge and more information is to come.

**Don Harrington:** That helps me and it makes sense because the member that told me this does have a physical disability. So probably why he got the letter. let's go down to the line Joan, one of my favorite repeat presenters

Joan McQuade: Thank you. Hi everybody. I'm Joan McQuade. I wanted to let you folks know that during the pandemic we had stopped. rejecting the community incidents because that was where they were putting all of the covid incidents all of the exposures Etc. And there were just hundreds of them. So I just want to let everybody know. We are now back to redacting the There's Community complaints Community So just when you seeing where did this come from? That's the reason why so once you start receiving incidents that we're either opened or closed in August. you will start seeing the community other incidents. And on a very happy note. We have a new redactor that's going to be starting the day after Memorial Day.
