We did have a backlog that we have provided to the IOC and that backlog was completed by Keith. That was the October reports. There were about two weeks, maybe three that we were behind on. **Michelle Rademacher:** We'll do the same thing so that it doesn't seem like it's a daunting task when you see those backlogs come in, which is what we did is we created a separate folder and labeled it with the backlog as such. So that it's less stressful and less daunting than seeing a whole bunch of unexpected folders loaded in the drive.

Keith Jansen: Understand

**Michelle Rademacher:** And then speaking of numbers, for the month of November, we loaded 814 total incident reports for the committee to review. And your committee has gone through all of those already. There were 50 open reports and 764 closed reports. So the open reports, what that means is, those are still under investigation. Those are the most recent triaged reports by our quality team.

Michelle Rademacher: And the closed reports, that means those reports are all closed for investigation and they will have findings noted in those reports as well. And that's pretty much all I have. I really want to thank the committee for your emails and your communication. You've been excellent with that. I usually know what's going on, as to who's going to be able to come to the meeting and if we're going to have a potential for a quorum or not and that's greatly appreciated. And then I also usually know what I need to move out of those folders so that it's easier for you to get in and read the most recent uploads. So we really do appreciate your communication and your feedback. It does help and make a difference. So thank you very much.

**Joseph Jensen III:** I might have missed this. Was there a total for the questions for November that were submitted and returned for District South?

**Michelle Rademacher:** So the total of questions I have here for November, there was a lot. It was 71 questions from the IOC committee for November.

Joseph Jensen III: Okay, thank you. I hadn't caught that.



**Michelle Rademacher:** Yeah. No, I think I skipped over that. Thank you for helping me with that. I appreciate it.
