But we also have a vacancy as well. So, just want to let you guys know we're continue to work on that. and Katrine, anything else to add?

Katrien Filez: Thank you, I think you covered it all. Dean is the tites reviewing the north beaver plans. Also helping out district east where we have a vacancy for the chair position. That's why the district north beaver plans are scheduled out a little farther out than usual. But thanks again Dean for all the support you're providing. Maybe at the same time I'd like to spread the word the position as a PRC chair in district is not yet posted. Hopefully very soon. But if you know of anybody who would be a great fit, who would be interested, please let them know that very soon we will have a code description or link a link that we can share with you. And that's about it.

Don Harrington: Okay. Dean, are you guys getting enough volunteers?

I know District East, we have some new ones. but, it's mostly I would say my standbys. they're volunteering and they're showing up and there for us. I wouldn't say they're new. a lot of support coordinators are helping out which is good because then they help out other support coordinators and that information goes around. but yeah, for the most part, District North, we have my go-to people definitely.

Joan McQuade: My mouse is never where it's supposed to be. Hi again, everybody. we're fully staffed and at this point we've had no backlog now for at least a few months, which is great. So, you should be getting all of your incident reports timely. And that's all I've got for unless you've got any questions.

Don Harrington: Okay. no questions. We'll move to Larry. I got him. Yes.

Updates from Health Plan Liasions

Don Harrington: I actually attended their last meeting, I want to say, and it's kind of interesting. A lot of Q&A. And the rest I'll just go down the line. Fredreaka.

Fredreaka Graham: Is that Fredreaka?

Don Harrington: Yeah, Fredreaka, I'm sorry.

Fredreaka Graham: No worries.

Don Harrington: I have So, AHCCCS is not funded by the state, right? It's funded by was it title 10?

Fredreaka Graham: This is Fredreaka with AHCCCS and I don't have any updates, but happy to take any

questions that you may have.

Fredreaka Graham: I'm not sure I understand what your question is.

Don Harrington: Because has anybody heard if DDD finally got the makeup funding?

Fredreaka Graham: I have not but maybe one of the DDD counterparts can assist with that question.

Don Harrington: Angela, go ahead.

Angela Venne: Either I can speak to it or Christina can speak. I'll go first. it has not been app hearings were yesterday about House Bill 2945. It was approved at the House. it still needs to go through Senate and then to the governor's desk. So we don't have the supplemental funding approved at this point but we



are confident that they have every desire to come to some kind of negotiation. So we can finish off this fiscal year and then the budget for next fiscal year has also not been approved.

Don Harrington: right? So, I believe it was a Senate that disapproved the last one, right? No,...

Angela Venne: The last bill.

Don Harrington: the last time they tried to pass the makeup funding, was that the Senate or...

Angela Venne: Yes. the house. Yeah.

Don Harrington: the House? Yeah. anything you want to add, Christina? Okay.

Christina Hedges: I think it was the House Appropriations Committee.

Christina Hedges: No, Angie covered it. we continue to support the governor's proposal for the budget and we for the most part really just know as much as you all know as a public. So,

Don Harrington: Okay.

Angela Venne: And we are sending announcements every Friday.

Angela Venne: So if you're connected to the vendor announcement that's where you're going to see the updates every Friday coming out from Zane.

OLCR Discussion

Don Harrington: Let's trying to mark off my list here. Denise

Denice Roth: Sorry, I was on mute and hidden. I'm not sure what updates we have to provide. Shannon, can you take over for that one? I'm sorry.

Shannon Kirwan: Yeah, not a problem. So, Denise and I are both here from OLCR and as far as being fully staffed, we are not fully staffed yet, but we are working on it. And we can talk more about that as you guys ask us questions, but Denise's unit is fully staffed now and we are bringing on some additional help with our quick connect process and OLCR now is going to get an admin because our admin took a promotion. So, we are working to get all of our positions filled.

Don Harrington: So, I was talking to some of my providers and a coworker and we were trying to figure out how many renewals and initials do you guys go through a year? Do you have any idea?

Shannon Kirwan: We can pull up our metrics and Denise, maybe you can do that while I talk a little bit. So, every one of our developmental homes needs to be reviewed every year. So, Denise can tell you what our number is right now. I think it's around, 1300. I'm not and that's ballpark. we would have to break it out.



we'd have to run a real quick report to see how many initials, but that number that 1300 kind of eb and flows and over the past probably four years we've only gained about a hundred. but it is around 1300 that we have to renew every year.

Don Harrington: that was the kind of the topic of what we were talking about, the volume of work that you guys are responsible for, And I don't know. I just can't see me personally sitting down and reading all those reviews and the ones that come back to me. I mean, you guys catch stuff that, I wrote it and still didn't catch it. So, it is difficult work to say the least. So I will say that I get a call for people wanting to become licensed and I'll send out just the application and the caregivers guide and 95% of them I never hear again. So I think that's a really great weeding out process but they never give enough information on the caregiver guide. they ask a question in there and they'll give a two-word answer. Yeah, that's just not going to work. but I do appreciate the work that you guys do and the stress that comes with the reason why I wanted you here is that when I requested it was last month so how long are you guys between the time a renewal is entered that it's getting approved?

Shannon Kirwan: So,...

Don Harrington: You know what I mean?

Shannon Kirwan: and again, Denise can read off our most recent metrics, but right now, we are reviewing renewal applications that were submitted in February, so we're about two months behind. over the course of the past year we had our developmental home manager resigned as well as our concerns liaison also took a promotion. So that left that unit bare minimum and so we had to pull over some of our reviewers to help with our concerns. We were just trying to get the work covered as well as we could. So now we're trying to clean up that backlog. And again, we're still about two months behind. and we've got a plan to try and address that to keep moving forward and get that queued down,...

Shannon Kirwan: but it was based on some staffing issues that we experienced over the last 6 to nine months.

Don Harrington: Right. Right. I appreciate your work. that we do I think very important we do it every year as opposed to foster care where it's every other year. I think it's just really important and I appreciate your help on that. let's see. Do we have anybody else from DDD?

Shannon Kirwan: right? Sure.

Denice Roth: So, just to chime in really quick, we have 1344 developmental home licenses that we're responsible for as of right now.

Don Harrington: Okay. And last month we talked about the census for members who are actually in a group home or ADHD home or something like that. it was a little over 5,000, wasn't it? I can't remember who gave me that last month,...



Don Harrington: but Okay.

Shannon Kirwan: I don't know if we have anyone on here that would be from network. They're the ones that really get those reports from our qualified vendors and then aggregate that to give monthly numbers. So, I'm not hearing anybody, but network would be able to give us specific numbers.

Chat Message: cintya catalan: not at this time, thank you

Don Harrington: But my point being is that there's still a lot of renewals. that's the crux of what I was getting at. A lot of renewals. And when you're short one person it really throws everything out of kilture.

Shannon Kirwan: Mhm.

Don Harrington: Does any of the board members have any questions as we go through? again I really want to thank OLCR for being here. I think the best way to relieve frustration is with knowledge and what you provided tonight really helps a lot. I'm going to spread the word. So, I appreciate you guys being here and same with everybody else. I actually look forward to this every month. thinking about retiring soon, but I'm going to keep this one. So, you guys are stuck with me. is there any other business Morgan that we need to talk about?

Ashley Mason MSW: I have something. You forgot about me again,...

Don Harrington: My gosh.

Ashley Mason MSW: Don. Freaking Dawn.

Don Harrington: And you are first on the list, too. I apologize. Okay, Ashley.

Ashley Mason MSW: I was waiting the whole time. I knew it. I was like, "Today he's gonna forget me." And you forgot Dawn, too. I'm not leaving Dawn out. So I really don't have any updates.

Don Harrington: she's at the bottom of the list, so go ahead.

Ashley Mason MSW: I just really wanted to say that you forgot me and it's okay because I'll see you at connections conference and then when you make eye contact with me, I'll just look away for five seconds to act like I don't know you and then I'll be like, " my god, D." That's true. But that would be mean.

Don Harrington: or you could forget my name.

Ashley Mason MSW: I'm Not in person. You're welcome.

Don Harrington: Gone.

Dawn McReynolds UHC OIFA: Hi, Don. Thank you. Thanks, Ashley. It's great to see you. Don, I do have an update and I apologize to those of that have heard this over and over and over again on every IOC that I attend, but we as OIFA have what we call credentialed family support individuals that work in behavioral



health and along with DDD members that receive those services. Christina Hedges kind of leads us in presenting to the DDD IOC's and we've made presentations through the DDD IOC's before. So, these individuals are prepared. They have to take a training for over 40 hours. They get confirmations from access that they are credentialed to work in behavioral health with individuals. and I think it's a very important resource for our families. So that's my soap box.

Dawn McReynolds UHC OIFA: Thanks for allowing me on it and I'll mute unless there's any questions.

Don Harrington: Do you have a lack of a better word, like a brochure or flyer or something you can send me that's got more details about that?

Family the Peer support is for the member in particular. they join the person kind of along their healthcare journey. both of these are behavioral health services. So they do go through our subcontractors United and Mercy Care. However, as our subcontractors, we have oversight of their oversight of the providers and I specifically am the one within the division that kind of ma oversees that entire benefit for peer support and family support. If you do have any questions, Don, please or anybody on the committee, please don't ever hesitate to reach out. But I will send Morgan and Michelle there's a few, we call them AHCCCS one pagers that really lay out nicely what these services look like and how to get them and how to then also become credentialed.

Don Harrington: So these are volunteer positions.

Christina Hedges: No, they're paid positions. They're primarily with either a behavioral health home or sometimes with a peerrun agency or a family run agency and they bill, the AHCCCS plan that a member has and...

Don Harrington: Okay.

Christina Hedges: they're put on the member's treatment plan as well. And there's services or goals related to those specific services that help kind of justify why it's medically necessary for those services to be put in place.

Don Harrington: So that is very fascinating. So cool. I mean, I just know a cursory amount of information that I use in my job, but yeah, it's much needed. So, absolutely. Thank you so much. Ashley, did I forget anybody else?

Ashley Mason MSW: No, you got me. But I think you're talking to Morgan.

Don Harrington: So there is a Morgan, what did we put in the chat?

Dawn McReynolds UHC OIFA: Ashley. Yeah, Ashley put more information about what we were talking about peer and credentialed stuff for you to review from her
