Therefore, pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment will be limited to directing staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date.

Under A.R.S. § 38-431.03(A)(3), the Board/Committee may vote to go into executive session for legal advice, which will not be open to the public.

At its discretion, the Board/Committee may consider and act upon any agenda item out of order. Members may appear by electronic means. The agenda for the meeting (subject to change up to 24 hours before the meeting) is as follows:

- C. CALL TO THE PUBLIC

Persons who want to address the committee do not need to request permission in advance. Each person who wants to address the committee will be given three (3) minutes to do so. Pursuant to A.R.S. § 38431.02(H), the committee can discuss or take action only on matters that are listed on the Agenda. Committee action on issues that are not listed on the Agenda is limited to directing staff to study the matter or to schedule the matter for further discussion at a future meeting.
